TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, Tessenderlo Group launched a share repurchase program in early April 2023 for an amount not exceeding 40 million EUR. As the share price is currently quoted below its book value, as well as taking into account the liquidity position of the group, the Board of Directors of Tessenderlo Group is of the opinion that it is opportune to proceed with the repurchase of its own shares.

Between June 5 and June 6, 2023, Tessenderlo Group acquired 39,000 of its own shares at an average price of 29.43 EUR per share, for a total amount of 1,147,669.40 EUR. The transaction took place on the Euronext Brussels regulated market. Tessenderlo Group's Board of Directors executed the purchase as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022. As a result of this transaction, the company holds 252,913 of its own shares in total, or 0.30% of the total number of issued shares as of June 12, 2023. In addition, the company, through its subsidiary Verbrugge nv, still holds 21,860,003 of its own shares, or 25.58% of the total number of issued shares (being 85,472,762 shares).
